# RA19 EXEMPTION OF INCOME FROM EMPLOYMENT FOR MARRIED PERSONS RETURNING TO EMPLOYMENT

Article 12(w) of the Income Tax Act (Cap 123)

This form is to be completed only by married persons:

- who have been absent from any gainful occupation for at least five years; and whose name was not during the said time on the unemployment register (Parts 1 and 2) as established by JobsPlus; and
- who are over forty years of age; and
- who have returned to employment (other than those holding an office of director or self employment); and
- their income from employment does not exceed €9,840; and
- provided that the said person is chargeable to tax using the married rates.
- This exemption shall apply for a period of five consecutive years of assessment commencing from the basis year in which the person started to work.
