**Deduction for Fees Paid in Respect of Tertiary Studies
Article 14F, Income Tax Act**

This form is to be used by individuals claiming a deduction of fees in respect of successfully completed studies at a recognised tertiary education institution.

This form together with a copy of the receipt of the fees paid and a certificate showing the completed program awarded by the relative institution, such certificate being confirmed as of a tertiary education level by either the University of Malta, the Malta College of Arts, Science and Technology, the Institution of Tourism Studies or if the qualification is conferred by another institution by the Malta Qualifications Recognition Information Centre, should be attached to the tax return.

Any part of the deduction that cannot be set off against the income of the individual or of his/her spouse in the year in which the studies were successfully completed, must be carried forward and set off against the income for subsequent years in succession.

The amount in box 3 of this form is to be transferred to box 19f of the income tax return.
