**ECO-CONTRIBUTION ACT
(CAP. 473)**

**Eco-Contribution (Form and Administrative Fee for Appeals)
Regulations, 2007**

IN exercise of the powers conferred by article 22 (5) and (6) of the Eco-Contribution Act, the Minister for Rural Affairs and the Environment, with the concurrence of the Prime Minister and Minister of Finance, has made the following regulations:

- Citation. **1.** The title of these regulations is the Eco-Contribution (Form and Administrative Fee for Appeals) Regulations, 2007.
- Appeal form. **2.** A person who receives and is notified of an assessment in terms of article 13A of the Eco-Contribution Act, or who is notified with a judicial act referred to in article 18(2) of the same Act, may within thirty days from the date of such notification lodge an appeal before the Appeals Board objecting to the administrative penalties so fixed. Such appeal shall be made by filing before the Appeals Board the appeal form established under the Schedule to these regulations.
- Administrative fee. **3.** An administrative fee of Lm25 shall be paid to the Secretary of the Appeals Board by any person lodging an appeal.
- Revokes L.N. 273 of 2007. **4.** The Eco-Contribution (Form and Administrative Fee for Appeals) Regulations, 2007 are hereby revoked.
